

The Trial Chamber is seized of the "Prosecution's Request for Extension of the Page Limit of its Summary of Presentation of Evidence" filed on 28 October 2009 ("Request"), which requests an extension of the 20 pages page limit to 75 pages pursuant to Regulation 37(2) of the Regulations of the Court.<sup>1</sup> During the status conference on 7 October 2009, the Chamber ordered that this summary is filed by 16.00 on 4 November 2009.<sup>2</sup>
2. The defence has indicated by email on 28 October 2009 that it does not oppose the Request.<sup>3</sup>
3. For the reasons set out in the Request, pursuant to Regulation 37(2), the Trial Chamber hereby grants an extension of the page limit up to 75 pages.
