**I, Judge Sylvia Steiner**, Presiding Judge of Pre-Trial Chamber I ("the Chamber") at the International Criminal Court ("the Court");

**NOTING** the oral decision rendered during the hearing of 30 October 2009, whereby the Chamber, *inter alia*, granted the Legal Representatives of Victims until Monday 16 November 2009 to file their final written observations;<sup>1</sup>

**NOTING** the "Requête aux fins d' extension du délai fixé par la Chambre Préliminaire pour le dépôt des observations écrites finales des représentants légaux des victimes" of 13 November 2009 (the "First Request"), whereby Ms. Hélène Cissé, Legal Representative of victims a/0434/09,a/0435/09,a/0456/09 to a/0462/09, a/0579/09 and a/0580/09 and Mr. Brahima Koné, Legal Representative of victims a/0170/09 to a/0192/09 requested the Chamber to be granted until Monday 23 November 2009 to submit their final written observations;<sup>2</sup>

**NOTING** the "Decision on the Legal Representatives of Victims' Request" of 13 November 2009, whereby the Presiding Judge granted Ms. Hélène Cissé and Mr. Brahima Koné until Monday, 23 November 2009 to submit their final written observations;<sup>3</sup>

**NOTING** the "Victims' request for an extension of time to file written observation" of 19 November 2009 (the "Second Request"), whereby Mr. Akin Akinbote, Legal Representative of victims a/0535/09, a/0537/09 to a/0542/09, a/0544/09 to a/0551/09

NOTING regulation 35(2) of the Regulations of the Court (the "Regulations");

**CONSIDERING** that the Second Request, contrary to the First Request, has been made after the expiration of the time limit established by the Chamber, and that Mr. Akinbote failed to demonstrate that he was unable to file his request within the time limit for reasons outside his control, as provided for in regulation 35(2) of the Regulations;

#### FOR THESE REASONS,

**REJECT** the Second Request.
