- 1. Trial Chamber III ("Chamber") is seized of the "Requête de la Défense aux fins d'extension de délai conformément à la Norme 35 du Réglement de la Cour" ("Request")<sup>1</sup> filed on 7 April 2010, which requests a 3 working day extension of the time limit<sup>2</sup> in which to file its reply to the observations by the Office of the Prosecutor ("prosecution")<sup>3</sup> and the legal representatives<sup>4</sup> on the defence "Application Challenging the Admissibility of the Case pursuant to Articles 17 and 19(2)(a) of the Rome Statute" ("Application on admissibility of the case") in the case *Prosecutor v Jean-Pierre Bemba Gombo*, filed on 25 February 2010.<sup>5</sup>
- 2. At the status conference of 29 March 2010, the Chamber granted the Office of the Public Counsel for the Victims ("OPCV") an extension of time to 1 April 2010 to file its observations on the Application on admissibility of the case. In consequence, the Chamber ordered that "[t]he Defence time limit for a response is extended, in turn, from 7 to 9 April at 16.00 hours".<sup>6</sup>
- 3. The defence submits that although the 42 page submission of the OPCV (in English) with 102 annexes was filed on 1 April 2010, the defence was only notified on 6 April 2010, thereby reducing the time for reply to 3 working days, for reasons outside of its control.<sup>7</sup> In addition, the defence submits that it needs to translate the submission in order properly to analyse its content.<sup>8</sup>

- 4. Given these circumstances, the defence submits that it will not be able adequately to prepare a reply within the existing timeframe. Therefore, pursuant to Regulation 35 of the Regulations of the Court, the defence requests an extension of 3 working days in order to file its reply.<sup>9</sup>
- The prosecution and the OPCV have indicated by email on 8 April 2010 that they do not oppose the Request.<sup>10</sup>
- 6. In light the late notification date, 6 April 2010, which was four days after the filing of the OPCV's submissions, and given the extent of the materials, the Chamber accepts that an extension of time is necessary, and good cause has been demonstrated, pursuant to Regulation 35(2) of the Regulations of the Court.
- For these reasons, the Chamber hereby extends the relevant time-limit to 14 April 2010 by 16.00.
