**I**, **Judge Cuno Tarfusser**, Single Judge responsible for carrying out the functions of Pre-Trial Chamber I in relation to the proceedings of the situation in Darfur, Sudan (the "Situation") and any related cases emanating therefrom<sup>1</sup> at the International Criminal Court (the "Court");

**NOTING** the "Second Decision on the Prosecutor's Application under Article 58", dated 27 August 2009, issuing *inter alia* a summons to appear for Abdallah Banda Abaker Nourain ("Banda") and Saleh Mohammed Jerbo Jamus ("Jerbo");<sup>2</sup>

**NOTING** the "Decision Setting the Date for the Hearing of First Appearance", issued on 15 March 2010, whereby the Chamber decided to schedule for Thursday 17 June 2010 the hearing of first appearance of Banda and Jerbo before the Court pursuant to article 60 of the Statute of the Court;<sup>3</sup>

**NOTING** articles 57(3)(c), 67 of the Statute of the Court and regulations 20 and 23bis (3) of the Regulations of the Court;

**CONSIDERING** that, in light of the upcoming hearing of first appearance and with a view to safeguarding the paramount principle of publicity of the proceedings before the Court as enshrined in the statutory texts, it is necessary to reclassify a certain number of documents contained in the record of the Case which are currently classified as "under seal";
