Decision Setting a New Date for the Initial Appearance

PRE-TRIAL CHAMBER II (the “Chamber”) of the International Criminal Court issues this decision to set a new date for the initial appearance of the three persons summoned in the case of *The Prosecutor v. Francis Kirimi Muthaura, Uhuru Muigai Kenyatta and Mohammed Hussein Ali*.

1. On 8 March 2011, the Chamber, by majority, decided to summon Francis Kirimi Muthaura, Uhuru Muigai Kenyatta and Mohammed Hussein Ali to appear before the Court (the “8 March 2011 Decision”).¹

2. The Chamber recalls article 60(1) of the Statute and rule 121(1) of the rules according to which a person subject to a summons under article 58 “shall appear before the Pre-Trial Chamber” and be informed of, the crimes he is alleged to have committed, his rights under the Statute, as well as to set up a date for a hearing on whether to confirm the charges or not.

3. The Chamber also recalls that in its 8 March 2011 Decision, it has decided to set Thursday, 7 April 2011 at 14.30 hours, as the date for the three persons to appear before the Chamber.²

4. The Chamber notes that it has received recent information that during the afternoon of April 7 2011, the Courts’ rooms are occupied with hearings related to the Trial Chambers. Accordingly, the Chamber considers it necessary to fix an alternative date and time to hold the said hearing.

FOR THESE REASONS, THE CHAMBER HEREBY

a) decides to convene the hearing for the initial appearance of Francis Kirimi Muthaura, Uhuru Muigai Kenyatta and Mohammed Hussein Ali **on Friday, 8 April 2011 at 14.30 hours.**






