I, Judge Cuno Tarfusser, the Duty Judge of the International Criminal Court ("Court");

NOTING the "Defence Challenge to the Jurisdiction of the Court" ("Defence Jurisdictional Challenge")¹, submitted on 19 July 2011 by the Defence;

NOTING the "Decision on the 'Defence Request for Reclassification' dated 14 July 2011 and on the request for reclassification of the 'Defence Challenge to the Jurisdiction of the Court" dated 20 July 2011, deciding inter alia to reclassify as public the Defence Jurisdictional Challenge as well as Annexes A and D thereto;²

NOTING articles 19(2) and 57(2)(a) of the Statute of the Court, rule 58(3) of the Rules of Procedure and Evidence ("Rules") and regulation 17 of the Regulations of the Court;

CONSIDERING that, pursuant to rule 58(3) of the Rules, the Prosecutor shall be allowed to submit written observations to an application under article 19(2) of the Statute "within a period of time determined by the Chamber";

CONSIDERING that the proximity of the date set for the commencement of the confirmation hearing makes it necessary to set a short time-limit for the Prosecutor to submit his observations on the Defence Jurisdictional Challenge;

CONSIDERING that, due to the current period of judicial recess, Pre-Trial Chamber I is unavailable;

CONSIDERING that, in light of the proximity of the confirmation hearing, the Duty Judge is satisfied that the matter is urgent and that it is appropriate for him to deal with it;
