Pre-Trial Chamber I of the International Criminal Court ("Chamber" and "Court" respectively), hereby renders the following decision:

NOTING the "Prosecution's Submissions on the Prosecutor's recent trip to Libya", filed on 25 November 2011 ("Prosecution Submission"),¹ wherein the Prosecutor: (i) alleges that he has spoken with the Libyan authorities regarding the issues surrounding the potential surrender of Saif Al-Islam Gaddafi to the Court² and (ii) wishes to convene a status conference providing further details ("Status Conference Request");³

CONSIDERING that the Prosecution has already described their discussion with the Libyan authorities at length in the Prosecution Submission, making it unnecessary to hold a status conference at this time;

FOR THESE REASONS

REJECTS the Status Conference Request.
