Pre-Trial Chamber III (the "Chamber") of the International Criminal Court (the

"Court") issues the following order scheduling the first appearance of

Mr Laurent Koudou Gbagbo ("Mr Gbagbo") for 5 December 2011 and

authorising photographs to be taken at that hearing.

1. On 23 November 2011, the Chamber issued its Warrant of Arrest against

Laurent Koudou Gbagbo ("Warrant of Arrest").1

2. On 30 November 2011, the Registrar informed the Chamber that Mr Gbagbo

had been surrendered to the Court, and that he is currently in the custody of

the Court at the detention centre in The Hague.

3. The Chamber has taken account of Articles 60(1) and 67 of the Rome Statute,

Rule 121(1) of the Rules of Procedure and Evidence (the "Rules") and

Regulations 20 and 21 of the Regulations of the Court (the "Regulations").

4. In particular, i) pursuant to Rule 121(1) of the Rules, Mr Gbagbo is to appear

before the Chamber promptly upon arriving at the Court and ii) pursuant to

Regulation 21 of the Regulations, the publicity of hearings may extend

beyond the courtroom.

FOR THESE REASONS, THE CHAMBER HEREBY

DECIDES to convene a public hearing on 5 December 2011 at 14 hours in Courtroom I, at which Mr Gbagbo shall appear before the Chamber in the presence of the Prosecutor and his Defence Counsel;

DECIDES to authorise the Registrar to inform external photographers that they will be authorised to take photographs in the Courtroom of the participants and the person subject to the arrest warrant (but for the latter only with his express consent) for a period of one minute immediately after the participants have taken their seats and before the judges enter the Courtroom;² and

ORDERS the Registrar to notify this decision to Mr Gbagbo and his Defence Counsel.
