**Pre-Trial Chamber I** ("Chamber") of the International Criminal Court ("Court") issues the following decision.

- 1. On 27 June 2011, the Chamber issued a warrant of arrest against, among others, Saif Al-Islam Gaddafi ("Mr Gaddafi").<sup>1</sup>
- 2. On 6 December 2011, a decision was issued ("6 December 2011 Decision")<sup>2</sup> wherein the Chamber: (i) after considering regulation 77 of the Regulations of the Court ("Regulations"), authorised the OPCD to represent the interests of the Defence in all instances related to the proceedings against Mr Gaddafi until otherwise decided by this Chamber³ and (ii) declined to appoint counsel for Mr Gaddafi before receiving confirmation that a power of attorney was given to a specific counsel.<sup>4</sup>
- 3. From 29 February 2012 to 4 March 2012, pursuant to a decision of the Chamber ordering a visit to Libya,<sup>5</sup> a joint Registry-OPCD delegation visited Libya. A visit to Mr Gaddafi by part of this delegation took place on 3 March 2012. The OPCD filed confidential, *ex parte* reports regarding this visit on 2 March 2012<sup>6</sup> and 5 March 2012.<sup>7</sup> In the latter report ("5 March 2012 OPCD Report"), the OPCD informed the Chamber that Mr Gaddafi requested for the OPCD to either select counsel or help him to select counsel.<sup>8</sup> During the visit, Mr Gaddafi also signed a declaration stating that he was willing for the OPCD

to continue to represent him before the Court until a counsel is appointed ("Gaddafi Declaration").9

- 4. The Chamber has considered rule 22 of the Rules of Procedure and Evidence and regulations 74, 75, 76 and 77 of the Regulations.
- 5. The Chamber notes that, per the Gaddafi Declaration, Mr Gaddafi indicates that he has no objection to being represented before the Court by the OPCD at this time. While the Gaddafi Declaration is not a formal power of attorney, the Chamber is mindful of the practical difficulties the OPCD faces in relation to representing Mr Gaddafi's interests, including trying to ascertain Mr Gaddafi's choice of counsel if indeed he wishes to have legal representation appointed for him. 10 Under the present circumstances, the Chamber finds the Gaddafi Declaration to be sufficient evidence that Mr Gaddafi would like for the OPCD to fully represent him until such time as regular counsel is appointed.
- 6. As such, the Chamber considers it in the interests of justice to appoint counsel from the OPCD to represent Mr Gaddafi at this point in time pursuant to regulation 76(2) of the Regulations.

## FOR THESE REASONS, THE CHAMBER HEREBY

APPOINTS Xavier-Jean Keïta and Melinda Taylor from the OPCD as counsel for Mr Gaddafi; and

**REMINDS** the OPCD to continue to assist Mr Gaddafi in acquiring counsel, consistent with his wishes.
