- 1. In light of the issues raised during the status conference on 11 June 2012¹ and pursuant to Regulations 34, 35 and 37 of the Regulations of the Court ("Regulations"), the Chamber amends its order of 14 May 2012² and sets a new deadline of 4 July 2012 for submissions from the Office of the Prosecutor and the legal representative addressing Regulation 55 as well as the interpretation in law of the mode of criminal responsibility applicable in the present case. These submissions are not to exceed 30 pages.
- 2. Thereafter, pursuant to Regulations 24, 34 and 37 the defence will have 21 days to respond by way of written submissions not to exceed 30 pages.
