Trial Chamber III of the International Criminal Court in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* issues the following Order convening an *ex parte* status conference.

By email of 30 November 2012, the defence requested the Chamber to convene an *ex parte* status conference – defence, Registry and Victims and Witnesses Unit ("VWU") only – in order to "discuss [...] the most efficient and effective way of proceeding to ensure the uninterrupted flow of witnesses in the new year".¹

Further to this request and pursuant to Rule 132(2) of the Rules of Procedure and Evidence, the Chamber grants the defence's request and therefore ORDERS that

(a) an *ex parte*, defence, VWU and Registry only, status conference will be held at 09.30 on Tuesday, 11 December 2012, in closed session, to address the presentation of evidence by the defence as of January 2013; and

(b) the attendees at the status conference will be the defence and representatives of the VWU and the Registry.
