**Trial Chamber V** ("Chamber") of the International Criminal Court ("Court") in the case of *The Prosecutor v. Uhuru Muigai Kenyatta*, pursuant to Regulations 23bis and 42 of the Regulations of the Court, issues this Order authorising disclosure of lesser redacted versions of victims' applications.

1. On 12 February 2013, the Office of the Prosecutor ("Prosecution") filed the "Prosecution's request for authorisation to disclose with lesser redactions victims' applications related to Prosecution witnesses" ("Application").<sup>1</sup> The Prosecution requests permission to disclose with lesser redactions seven victims' applications relating to five Prosecution trial witnesses.<sup>2</sup> These applications were previously disclosed to the defence for Mr Kenyatta ("Defence") with redactions consistent with those applied by the Registry in the redacted versions of the annexes to the submissions transmitting victims' applications before Pre-Trial Chamber II.<sup>3</sup>
2. The Defence did not file any response to the Application.
3. The Prosecution indicates that it intends to disclose the seven applications with limited redactions applied to contact information of witnesses and third parties, in accordance with the Chamber's Decision on the protocol establishing a redactions regime and annexed Protocol ("Redaction Protocol").<sup>4</sup>
4. As an initial matter, the Chamber observes that there is no longer any justification for the redactions at issue to be maintained vis-à-vis the Defence. The Chamber considers that although the Redaction Protocol provides for ongoing redactions to the contact information of "other persons at risk as a result of the activities of the


Court",<sup>5</sup> it is silent as to redactions to the contact information of witnesses. Nevertheless, given that the Protocol on the handling of confidential information and contacts with witnesses whom the opposing party intends to call<sup>6</sup> makes clear that contacts with witnesses of another party should be facilitated by the calling party,<sup>7</sup> and as there is no suggestion that the contact information of these five witnesses is relevant to any aspect of the present case, the Chamber authorises the Prosecution's request to disclose lesser redacted versions of the applications.

**The Chamber hereby authorises** the Prosecution to disclose lesser redacted versions of the victims' applications related to Witnesses 390, 363, 387, 388 and 427.


