**Judge Silvia Fernández de Gurmendi**, Single Judge for Pre-Trial Chamber I (the "Chamber") of the International Criminal Court (the "Court"), responsible for carrying out the functions of the Chamber in relation to the situation in the Republic of Côte d'Ivoire and the cases emanating therefrom,<sup>1</sup> hereby issues the decision on the "*Demande de notification au Représentant légal commun des observations déposées par la Défense sur les questions abordées lors de l'audience de confirmation des charges*" (the "Request"), submitted by the Office of Public Counsel for victims (the "OPCV").<sup>2</sup>

1. On 28 March 2013, the Defence filed its "*Soumissions écrites de la défense portant sur un certain nombre de questions discutées lors de l'audience de confirmation des charges*" (the "Defence Final Observations").<sup>3</sup> On 3 April 2013, the Defence filed a public redacted version.<sup>4</sup>

2. On 2 April 2013, the OPCV filed the Request, requesting that the Defence Final Observations be notified to it.<sup>5</sup> In support of this request, the OPCV submits that it participated throughout the sessions of the confirmation of charges hearing and that the Chamber has stated on several occasions that the final written observations of the parties and participants should be limited to issues discussed at the hearing.<sup>6</sup>

3. No responses were received to the Request from the Prosecutor or the Defence.

4. The Single Judge notes regulation 23 *bis* of the Regulations of the Court.


