Pursuant to regulation 28 of the Regulations of the Court,


Issues the following

ORDER

1. The Registrar shall file, by 3 June 2013, to the extent possible, public redacted versions of the following documents:
 - a) “Conclusions de l’évaluation de la situation sécuritaire de M. Mathieu Ngudjolo conduite par l’Unité d’aide aux victimes et aux témoins” (ICC-01/04-02/12-25-Conf-Exp-Anx1);
 - b) “Registry’s update on the situation in relation to Mathieu Ngudjolo Chui” (ICC-01/04-02/12-69-Conf-Exp).

2. Mr Ngudjolo shall file, by 10 June 2013, a public redacted version of his “Réplique de la Défense de Mathieu Ngudjolo aux « Observations du Greffe en application de la norme 24bis du Règlement de la Cour au sujet du « SECOND ADDENDUM à la « Requête de la Défense tendant à obtenir de la Chambre d’appel une injonction donnée à l’Unité d’aide aux victimes et aux témoins d’exécuter, et à l’Etat hôte de respecter le jugement d’acquittement du 18 décembre 2012 rendu par la Chambre de première instance II de la Cour pénale internationale » ” (ICC-01/04-02/12-48-Conf).
