Pre-Trial Chamber II (the "Chamber") of the International Criminal Court (the

"Court") issues this decision regarding the "Prosecution's notification of travel in

the case of The Prosecutor v Omar Al Bashir" (the "Prosecutor's Notification").1

1. On 31 March 2005, the Security Council (the "SC") acting under Chapter VII

of the Charter of the United Nations adopted Resolution 1593 (2005) referring the

situation in Darfur to the Court.2

2. On 4 March 2009 and 12 July 2010, Pre-Trial Chamber I ("PTC I") issued two

warrants of arrest against Omar Hassan Ahmad Al-Bashir ("Omar Al-Bashir")³.

These warrants of arrest remain to be executed.

3. On 6 March 2009 and 21 July 2010, the Registry, acting upon PTC I's request,

issued the "Request to all States Parties to the Rome Statute for the arrest and

surrender of Omar Hassan Ahmad Al Bashir"⁴ as well as the "Supplementary

request to all States Parties to the Rome Statute for the arrest and surrender of

Omar Hassan Ahmad Al Bashir". 5 These requests called for the cooperation from

all States Parties in the arrest and surrender of Omar Al-Bashir, pursuant to, inter

alia, articles 89(1) and 91 of the Rome Statute (the "Statute").

4. On 15 March 2012, the Presidency issued the "Decision on the constitution of

Pre-Trial Chambers and on the assignment of the Democratic Republic of the

Congo, Darfur, Sudan and Côte d'Ivoire situations", in which it re-assigned, inter

alia, the situation of Darfur, Sudan to this Chamber.6

5. On 15 July 2013, the Chamber received the Prosecutor's Notification, in which

she contends that, on the basis of media reports, Omar Al-Bashir has arrived in

the Nigerian capital, Abuja, to participate in the Special Summit of the African

Union on HIV/AIDS, Tuberculosis and Malaria, scheduled to take place from 12

to 16 July 2013.7 The Prosecutor further contends that the spokesperson of the

Nigerian President has stated that "[t]he Sudanese president came for an AU

event and the AU has taken a position on the ICC arrest order, so Nigeria has not

taken action different from the AU stand".8

6. The Chamber notes articles 86, 87(7) and 89 of the Statute.

7. The Chamber observes that the Federal Republic of Nigeria is a State Party to

the Statute since 27 September 2001 and, accordingly, it is under the obligation

pursuant to articles 86 and 89 of the Statute, to execute the pending Court's

decisions concerning the arrest and surrender of Omar Al-Bashir. The Chamber

expects the Federal Republic of Nigeria to immediately arrest Omar Al-Bashir

and surrender him to the Court.

8. The Chamber further notes that according to article 87(7) of the Statute

"[w]here a State Party fails to comply with a request to cooperate by the Court

contrary to the provisions of this Statute [...] the Court may make a finding to

that effect and refer the matter to the Assembly of States Parties or, where the Security Council referred the matter to the Court, to the Security Council".

FOR THESE REASONS, THE CHAMBER HEREBY

- a) requests the Federal Republic of Nigeria to immediately arrest Omar Al-Bashir and surrender him to the Court;
- **b) instructs** the Registry to immediately transmit the present decision to the Federal Republic of Nigeria;
- c) orders the Registry to prepare a report to the Chamber concerning Omar Al-Bashir's visit to the Federal Republic of Nigeria.
