Trial Chamber V(A) (the 'Chamber') of the International Criminal Court, in the case of *The Prosecutor v. William Samoei Ruto and Joshua Arap Sang*, having regard to Regulations 34 and 65(3) of the Regulations of the Court, issues this Order Regarding Responses to the Ruto Defence Request for Leave to Appeal the "Decision on the Prosecution's Requests to Add New Witnesses to its List of Witnesses" and related Requests.


1. On 3 September 2013, the Chamber issued the "Decision on the Prosecution's Requests to Add New Witnesses to its List of Witnesses" (the 'Decision'),¹ authorising the Office of the Prosecutor to add two persons to its list of witnesses.
2. On 4 September 2013, the defence team for Mr Ruto (the 'Ruto Defence') filed a request for leave to appeal the Decision, combined with a request for an adjournment of four weeks following the opening statements, and a request to vary the time limits for responses to its request for leave to appeal (the 'Ruto Defence Requests').²
3. In light of the commencement date of the trial and bearing in mind that part of the Ruto Defence Requests relates to the period immediately after the opening statements, the Chamber hereby directs the parties to present their responses to

the Ruto Defence Requests, if any, orally during the status conference scheduled for 9 September 2013.³


