Trial Chamber V(A) (the 'Chamber') of the International Criminal Court (the 'Court'), in the case of *The Prosecutor v. William Samoei Ruto and Joshua Arap Sang*, having regard to Regulation 34 of the Regulations of the Court (the 'Regulations'), issues this Order shortening time limit to respond to the 'Common Legal Representative for Victims' Comprehensive Report on the Withdrawal of Victims from the Turbo area by Letter dated 5 June 2013' .

1. On 30 August 2013, the Legal Representative of Victims (the 'LRV') filed the 'Common Legal Representative for Victims' Comprehensive Report on the Withdrawal of Victims from the Turbo area by Letter dated 5 June 2013' (the 'LRV Report').¹ A public redacted version of the LRV Report was filed on 5 September 2013.²
2. The Chamber notes that the LRV makes the following requests in the LRV Report:
 - a. That victims should still be presumed to be participating victims until they have communicated their individual withdrawal to the Common Legal Representative and/or the Court;³
 - b. That the Trial Chamber takes appropriate measures for further investigations in relation to the 'root cause for the withdrawal by victims from participation in the proceedings';⁴
 - c. That the Trial Chamber [REDACTED];⁵
 - d. That the Trial Chamber directs the Court's Security and Safety Section to undertake regular reporting procedures on security incidents in the field and


to provide security briefs to the Trial Chamber and to the LRV after the occurrence of security incidents.⁶

FOR THE FOREGOING REASONS, THE CHAMBER HEREBY


DIRECTS the parties file any responses to the LRV Report no later than 13 September 2013.
