

**CONSIDERING** that, in light of the subject-matter of the Request and with a view to its prompt disposal, it is appropriate to shorten the time limit for the Prosecutor’s response thereto, if any, and to set said time limit at Friday, 24 January 2014;

**FOR THESE REASONS, THE SINGLE JUDGE HEREBY**

**ORDERS** the Prosecutor to file her response to the Request, if any, by Friday, 24 January 2014.
