THE PRESIDENCY of the International Criminal Court (“Court”);

NOTING the request for excusal filed before the Presidency on 24 January 2014 by Judge Eboe-Osuji (“judge”) pursuant to article 41(1) of the Rome Statute of the International Criminal Court (“Statute”) and rule 33 of the Rules of Procedure and Evidence (“Rules”), wherein the judge requested to be excused from the case of *The Prosecutor v Uhuru Muigai Kenyatta* before Trial Chamber V(b)¹;

NOTING the decision of the Presidency of 30 January 2014, granting the judge’s request for excusal from Trial Chamber V(b) (Annex I);

CONSIDERING that the functions of the Trial Chamber shall normally be carried out by three judges of the Trial Division in accordance with article 39(2)(b)(ii) of the Statute;

CONSIDERING rule 38 of the Rules and regulation 15 of the Regulations of the Court providing for the replacement of judges;

HEREBY DECIDES to reconstitute Trial Chamber V(b) as follows effective 1 February 2014:


