I, Judge Cuno Tarfusser, having been designated as Single Judge of Pre-Trial Chamber II of the International Criminal Court;

NOTING the "Prosecution's request for variation of time limits pursuant to regulation 35 of the Regulations of the Court concerning the confirmation of charges" dated 3 March 2014, whereby the Prosecutor submits that "[s]everal factors beyond the Prosecution's control have rendered the schedule set in early December 2013 untenable" and, accordingly, requests "a four-month extension of the deadlines set by the Pre-Trial Chamber ... concerning the scheduling of proceedings regarding the confirmation of charges"; ("Prosecutor's Request");¹


NOTING that, pursuant to regulations 24(1) and 34(b) of the Regulations of the Court, the parties may file a response to any document filed in the record of the case within 21 days of notification thereof, unless otherwise ordered;

CONSIDERING that, in light of the subject-matter of the Request and with a view to its prompt disposal, it is appropriate to shorten the time limit for the responses thereto by the Defence teams, if any, and to set said time limit at Tuesday 11 March 2014;

FOR THESE REASONS, THE SINGLE JUDGE HEREBY

ORDERS the Defence teams to file their responses to the Prosecutor's Request, if any, by Tuesday, 11 March 2014.
