Trial Chamber IV (“Chamber”) of the International Criminal Court (“Court”) in the case of *The Prosecutor v. Abdallah Banda Abakaer Nourain* (“Banda case”), acting pursuant to Regulation 34 *chapeau* of the Regulations of the Court issues the following “Order suspending a deadline”.

1. On 6 March 2013, the Chamber issued the “Decision concerning the trial commencement date, the date for final prosecution disclosure, and summonses to appear for trial and further hearings”, in which it set the trial date for 5 May 2014.¹
2. On 20 March 2014, the Chamber issued the “Decision on the participation of victims in the trial proceedings”, in which it ordered the Common Legal Representative (“CLR”) to file no later than 17 April 2014 (“17 April 2014 deadline”) a schedule of the anticipated order of victims due to testify at trial.²
3. On 7 April 2014, the CLR filed a request for extension of the set deadline, arguing, *inter alia*, that she did not receive yet all confidential documents and evidence in the record of the *Banda case*.³
4. On 16 April 2014, the Chamber issued the “Decision vacating the trial date of 5 May 2014”.⁴
5. Consequently, the Chamber suspends the 17 April 2014 deadline and will decide on what further steps to take in due course.


