Trial Chamber III ("Chamber") of the International Criminal Court in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* issues the following Decision requesting the Registry's observations on the prosecution's request relating to Article 70 investigation.

- 1. On 15 November 2012, the Office of the Prosecutor ("prosecution") filed its "Prosecution Request for Record of Payments made by the Registry to Witnesses called by the Defence of Mr Jean-Pierre Bemba Gombo ("Request"), in which it informs the Chamber that it is currently conducting an investigation pursuant to Article 70 of the Rome Statute ("Statute"). To this end, the prosecution requests the Chamber to order the Registry to:
 - (i) provide the prosecution with the record of the payments effected by the Registry to defence witnesses who have testified or who are testifying in the future, including the three expert witnesses, on any ground related to their testimonies, either directly or through any intermediary person or persons; and (ii) provide the prosecution with information as to the amount of professional fees that the three defence expert witnesses were granted and paid.³
- 2. The Chamber notes the prosecution's submission that providing further information on its Article 70 investigation would be "premature" at this stage. In any event, in order to issue an informed decision on the matter, the Chamber finds it necessary to hear the relevant sections within the Registry on the prosecution's Request. Therefore, in accordance with Article 21 of the Statute and pursuant to Article 64(6)(f) of the Statute and Regulations 80, 84 to 87 of the Regulations of the Registry, the Chamber orders the Registry to file its observations on the Request, no later than 16.00 on 26 November 2012.
