The Appeals Chamber of the International Criminal Court,

In the appeals filed, on 24 August 2012, jointly by the Legal Representatives of Victims V01 and the Office of Public Counsel for victims on behalf of the victims they represent (ICC-01/04-01/06-2909), and, on 3 September 2012, by the Legal Representatives of Victims V02 on behalf of the victims they represent (ICC-01/04-01/06-2914), as well as, on 6 September 2012, by Mr Thomas Lubanga Dyilo (ICC-01/04-01/06-2917) against the decision of Trial Chamber I entitled "Decision establishing the principles and procedures to be applied to reparations" of 7 August 2012 (ICC-01/04-01/06-2904),

Having before it the "Prosecution's request for transmission by VPRS of the application for reparations of victim a/0078/06" of 9 April 2014 (ICC-01/04-01/06-3078-Conf), in which the Prosecutor requests that the Appeals Chamber order the Victims Participation and Reparations Section to file *ex parte*, Prosecution only, in the record of the case of *Prosecutor v. Bosco Ntaganda* an unredacted version of the application for reparations filed in the case of *Prosecutor v. Thomas Lubanga Dyilo* by victim a/0078/06,

Noting the "Observations de l'équipe VO2 de représentants légaux de victimes conformément à l'ordonnance ICC-01/04-01/06-3080-Conf de la Chambre d'appel", filed on 29 April 2014 (ICC-01/04-01/06-3081-Conf), in which the legal representatives of victim a/0078/06 indicate that they have no objection to the Prosecutor's request,

Pursuant to articles 64 (2) and 83 (1) of the Statute and rule 149 of the Rules of Procedure and Evidence


Issues the following
