**I, Judge Cuno Tarfusser,** having been designated as Single Judge of Pre-Trial Chamber II of the International Criminal Court;

**NOTING** the "Decision on the reclassification and filing into the record of material provided by the Dutch judicial authorities" dated 16 May 2014<sup>1</sup>;

**NOTING** the "Registry submissions related to the implementation of Decision ICC-01/05-01/13-403" dated 19 May 2014<sup>2</sup>, whereby the Registry, *inter alia*, informed that "the format and technical features of the CD and DVD received [by the Dutch authorities] were found to be not compatible with the electronic filing system of the Court and, as it was done previously with a similar situation, the Dutch authorities were contacted and asked to provide the relevant material in a technical format which would allow its filing before the Court";

**NOTING** the "Third Registry submissions related to the implementation of Decision ICC-01/05-01/13-403" dated 28 May 2014 ("Third Registry Submissions")<sup>3</sup>, whereby the Registry (i) informed that "on Monday 26 May 2014, the Dutch authorities provided the content of the CD and DVD in a format compatible with the electronic system of the Court" and (ii) filed the content of the CD and the DVD as confidential annexes thereto;

**NOTING** the "Defence request for a provision of a copy of the CD and DVD mentioned in the Registrar's submission ICC-01/05-01/13-410-Conf" dated 7 June 2014<sup>4</sup>, whereby the Defence for Mr Bemba requests the Single Judge "to order the immediate provision of a copy of the CD and DVD in question to Counsel and to the Suspect at his place of detention in order to permit the review of the contents thereof" ("Mr Bemba's Defence Request" or "Request");

**NOTING** the "Prosecution's Response to the Bemba Defence's Request for the Provision of a Copy of the CD and DVD Mentioned in the Registrar's Submission ICC-01/05-01/13-410-Conf" dated 10 June 2014<sup>5</sup>;

**CONSIDERING** that, in light of the Third Registry Submissions and of the filing of their contents, Mr Bemba already has full access to the CD and DVD in question;

**CONSIDERING** that, accordingly, the Request is moot;

FOR THESE REASONS, THE SINGLE JUDGE HEREBY

**DISMISSES** Mr Bemba's Defence Request.
