**I, Judge Cuno Tarfusser**, having been designated as Single Judge of Pre-Trial Chamber II of the International Criminal Court;

**NOTING** "Narcisse Arido's request for non-disclosure and/or redactions of data extracted from Mr Arido's mobile phones (ICC-01/05-01/13-452-Conf)" dated 10 June 2014 ("Mr Arido's Request")<sup>1</sup>, whereby the Defence for Narcisse Arido requests the Single Judge "to review the data contained in the mobile phones of Mr Arido with a view to identifying personal information which are not relevant to the case, those which can be disclosed and the others which should not" with a view to preventing disclosure of information of a private nature and prevent that third persons be put at risk;

**NOTING** articles 54(1)(a), 57(3)(b) and (c), 68 and 93(1)(h) of the Statute and rule 81(4) of the Rules of Procedure and Evidence;

**CONSIDERING** that the principle whereby information of an exclusively private nature, as such irrelevant for the purposes of these proceedings, should not be the subject matter of disclosure has been stated and acted upon throughout this case<sup>2</sup>;

**CONSIDERING**, on the one hand, that it would not be appropriate for the Single Judge to carry out the review of the data extracted from Mr Arido's mobile phones as requested;

**CONSIDERING**, on the other hand, that it is necessary that the Prosecutor be provided with the opportunity to review all the material seized upon the arrest of the suspects with a view to avoiding that the purpose of the seizures implemented upon their arrest be defeated, subject only to the need to avoid that material of a privileged nature be communicated to the Prosecutor;

**CONSIDERING** that, since no issue of privilege arises in connection with Mr Arido's telephones, it is appropriate that the same procedure as the one followed in respect of items seized upon the arrest of Fidèle Babala be likewise followed in respect of Mr Arido's mobile phones<sup>3</sup>;

**CONSIDERING** that, in accordance with her responsibilities, the Prosecutor shall carry out the review of Mr Arido's mobile phones by investigating "incriminating and exonerating circumstances equally";

## FOR THESE REASONS, THE SINGLE JUDGE HEREBY

**REJECTS** Mr Arido's Request;

**ORDERS** the Registrar to promptly transmit the data extracted from Mr Arido's telephones to the Prosecutor and to return such telephones to Narcisse Arido upon completion of such transmission.
