Judge Silvia Fernández de Gurmendi, Single Judge for Pre-Trial Chamber I (the "Chamber") of the International Criminal Court (the "Court"), responsible for carrying out the functions of the Chamber in relation to the situation in the Republic of Côte d'Ivoire and the cases emanating therefrom, hereby issues the decision on the Defence's "Requête de la défense afin d'être autorisée à déposer une demande d'autorisation d'interjeter appel de la «Decision on the confirmation of charges against Laurent Gbagbo» (ICC-02/11-01/11-656-Conf) du 12 juin 2014 excédant le nombre de pages prévu à la Norme 37(2) du Règlement de la Cour" (the "Request").<sup>2</sup>

- 1. On 12 June 2014, the Chamber, by majority, issued its decision confirming the charges against Laurent Gbagbo ("Mr Gbagbo").<sup>3</sup>
- 2. On 16 June 2014, the Chamber, upon request of the Defence, extended the time limit to file any request for leave to appeal the Confirmation Decision until five days following notification of the official French translation of the Confirmation Decision.<sup>4</sup>
- 3. On 18 July 2014, the official French translation of the Confirmation Decision and the appended dissenting opinion was notified.<sup>5</sup>
- 4. On 18 July 2014, the Defence filed the Request, asking the Chamber to authorise it to file a request for leave to appeal the Confirmation Decision

exceeding the ordinary page limit by thirty pages, thus bringing the total amount of pages to fifty, including footnotes.<sup>6</sup> In support of the Request, the Defence refers to the importance of the Confirmation Decision, <sup>7</sup> the complexity of the proceedings and of the Confirmation Decision, as well as its length,<sup>8</sup> the significance of the request for leave to appeal the Confirmation Decision, including the nature and number of questions and arguments which the Defence intends to present in a request for leave to appeal,<sup>9</sup> as well as the need to protect the rights of the Mr Gbagbo and the related role of the Chamber.<sup>10</sup>

- 5. The Single Judge notes article 82(1)(d) of the Rome Statute, rule 155(1) of the Rules of Procedure of Evidence and regulation 37 of the Regulations of the Court (the "Regulations").
- 6. In light of the arguments presented by the Defence in its Request, and taking into account the complexity and the length of the pre-trial proceedings in the present case which ultimately led to the Confirmation Decision, the Single Judge is of the view that there exist exceptional circumstances within the meaning of regulation 37(2) of the Regulations. Therefore, the extension of page limit as requested by the Defence can be granted.

## FOR THESE REASONS, THE SINGLE JUDGE

**GRANTS** the Defence up to 50 pages including footnotes for its request for leave to appeal the Confirmation Decision.
