Trial Chamber I ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Laurent Gbagbo*, having regard to Article 64(3) of the Rome Statute ('Statute'), Rule 132(1) of the Rules of Procedure and Evidence ('Rules') and Regulation 54 of the Regulations of the Court issues the following 'Order setting the agenda for the status conference of 4 November 2014'.

1. On 8 October 2014, the Chamber issued an order scheduling a status conference and setting a provisional agenda for the first status conference.¹ The Chamber instructed the parties and participants to file their observations on the issues mentioned in the provisional agenda and to indicate whether they wished to add any item to the agenda.
2. On 27 October 2014, the parties and participants filed their observations.²
3. Taking into account these observations, the Chamber hereby issues a final agenda for the status conference:
 - a) Timing, volume and modalities of disclosure of evidence pursuant to Rule 76 of the Rules;
 - b) Whether the Prosecution anticipates issues concerning the protection of witnesses and other persons (including the need for redactions), the disclosure of identities of witnesses, as well as referrals to the Court's witness protection program;



- c) Material already disclosed and intended to be disclosed by the Prosecution pursuant to Article 67(2) of the Statute and Rule 77 of the Rules;
- d) Update on victims' applications and the procedure for allowing victims to participate in the trial proceedings;
- e) Languages to be used in the proceedings, in particular, the languages spoken by the witnesses the parties intend to call and victims the legal representatives may seek authorisation to call;
- f) Subject to the Pre-Trial Chamber's decision on the confirmation of charges, possible joinder of *Gbagbo* and *Blé Goudé* cases;
- g) Imposition of deadlines to the Defence for the possible filing of pre-trial challenges;
- h) Filing of additional documents, such as an Elements-Based Chart, an In-depth Analysis Chart ('IDAC') and/or a Pre-trial Brief;
- i) The possibility of a site visit;
- j) E-court protocol (impact on Defence resources and possible changes thereto); and
- k) Commencement date of the trial.


FOR THE FOREGOING REASONS, THE CHAMBER HEREBY
