#### THE PRESIDENCY of the International Criminal Court ("Court");

**NOTING** the decision of Pre-Trial Chamber II dated 11 November 2014 which, *inter alia*, confirmed, pursuant to article 61(7)(a) of the Rome Statute of the International Criminal Court ("Statute"), the charges presented by the Prosecutor against Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido to the extent specified in pages 47-54 of that decision, and committed the Defendants for trial on the charges as confirmed ("Decision Confirming the Charges"); <sup>1</sup>

**NOTING** the request by each Defendant for leave to appeal the Decision Confirming the Charges;<sup>2</sup>

CONSIDERING the decision of Pre-Trial Chamber II dated 23 January 2015 rejecting each Defendant's request for leave to appeal the Decision Confirming the Charges, thereby concluding the proceedings in the case before that Chamber, and ordering the Registrar to transmit the Decision Confirming the Charges and the record of the proceedings to the Presidency for the purpose of constituting a Trial Chamber pursuant to article 61(11) of the Statute;<sup>3</sup>

**CONSIDERING** article 61(11) of the Statute, pursuant to which the Presidency shall constitute a Trial Chamber once the charges have been confirmed, which shall be responsible for the conduct of subsequent proceedings;

**CONSIDERING** rule 130 of the Rules of Procedure and Evidence ("Rules"), pursuant to which the Presidency shall refer the case to a Trial Chamber and transmit to it the Decision Confirming the Charges and the records of the proceedings of the Pre-Trial Chamber;
