Trial Chamber VII ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido*, having regard to Articles 64(2) and 67(1)(d) of the Rome Statute ('Statute'), Rules 20 to 22 of the Rules of Procedure and Evidence ('Rules'), Regulation 78(1) of the Regulations of the Court ('Regulations') and Articles 8, 15, 17 to 19 of the Code of Professional Conduct for counsel ('Code of Conduct'), renders this 'Decision on Defence counsel request to withdraw according to Regulation 78(1) of the Regulations of the Court'.

- 1. On 4 December 2013, Mr Mangenda designated Mr Jean Flamme ('Counsel') as counsel for his defence.<sup>1</sup>
- 2. On 2 February 2015, Counsel filed a request for leave to withdraw under Regulation 78(1) of the Regulations ('Request'),<sup>2</sup> citing health reasons as the motive for the Request.<sup>3</sup>
- 3. The Chamber, noting Counsel's wish to withdraw and the reasons given therefore, hereby grants the Request. The Chamber reminds Counsel that he remains subject to Articles 8, 15 and 17 to 19 of the Code of Conduct.
- 4. Further, having regard to Article 67(1)(d) of the Statute, the Chamber directs the Registry to take the necessary steps, in accordance with Rules 20 to 22 of the Rules, to ensure continuous legal representation of Mr Mangenda in order to protect his rights as an accused. To this end, the withdrawal of Counsel shall only take effect once a new defence counsel has been appointed for Mr Mangenda.
