**THE PRESIDENCY** of the International Criminal Court (“Court”);

**NOTING** the election of Judge Silvia Fernández de Gurmendi as President of the Court, Judge Joyce Aluoch as First Vice-President of the Court and Judge Kuniko Ozaki as Second Vice-President of the Court on 11 March 2015;<sup>1</sup>

**NOTING** article 39(1) of the Rome Statute of the International Criminal Court (“Statute”) and rule 4*bis* of the Rules of Procedure and Evidence;

**NOTING** the process by which the Presidency, following its establishment, has consulted with the judges in assigning them to the various divisions of the Judiciary;

**NOTING** the assignment of Judge Silvia Fernández de Gurmendi to the Appeals Division in accordance with article 39(1) of the Statute, pursuant to her election as President of the Court;

**NOTING** that when assigning judges to divisions, the Presidency considers a number of factors, including the previous involvement of judges in cases, assessing them on a case-by-case basis, and that the guiding principles informing these factors are the applicable statutory framework and the need to ensure the efficient management of the Court's workload;<sup>2</sup>

**NOTING** further that no single factor is absolute and that each factor must be followed only to the extent possible in the circumstances;<sup>3</sup>

**NOTING** that the 18<sup>th</sup> judge provided for under article 36(1) of the Statute has yet to be elected and is therefore not available for assignment;

**IDENTIFYING** which judges within the relevant divisions are available for assignment pursuant to article 39(1) of the Statute;<sup>4</sup>

**ASSESSING** the long term needs of the Court, particularly the avoidance of mandate extensions of judges and the promotion of efficiency by composing benches which will not need to be changed later;<sup>5</sup>

**NOTING** the relative judicial workload of each available judge;<sup>6</sup>

**NOTING** the experience and expertise of each judge;<sup>7</sup>

**SEEKING** to ensure, to the extent possible, gender and geographical balance and representation of the world's principal legal systems within each division;<sup>8</sup>

**HEREBY DECIDES** that the judges shall be assigned to the various divisions as follows:


