Trial Chamber IV

THE PRESIDENCY of the International Criminal Court notes that on 16 March 2012 Trial Chamber IV was composed of Judges Joyce Aluoch, Silvia Fernández de Gurmendi and Chile Eboe-Osuji.¹

On 11 March 2015, Judge Silvia Fernández de Gurmendi was assigned to the Appeals Division in accordance with article 39(1) of the Rome Statute of the International Criminal Court (“Statute”) pursuant to her election as President of the Court.²

On 13 March 2015, the Presidency assigned, *inter alia*, Judges Joyce Aluoch, Chile Eboe-Osuji and Geoffrey Henderson to the Trial Division in accordance with article 39(1) of the Statute and rule 4*bis*(2) of the Rules of Procedure and Evidence (“Rules”).³

The Presidency recalls article 39(1), (2)(b)(ii) and (4) of the Statute, rule 38 of the Rules and regulation 15(1) of the Regulations of the Court.

The Presidency hereby decides to recompose Trial Chamber IV as follows effective 17 March 2015:

Judge Chile Eboe-Osuji

Judge Geoffrey Henderson


