THE PRESIDENCY of the International Criminal Court notes that on 13 March 2015, Judge Robert Fremr filed a request before the Presidency pursuant to article 41(1) of the Rome Statute of the International Criminal Court (“Statute”) and rule 33(1) of the Rules of Procedure and Evidence (“Rules”), wherein Judge Fremr requested to be excused from his function as a judge of Trial Chamber VII in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo and Fidèle Babala Wandu and Narcisse Arido*.

On 17 March 2015, the Presidency granted Judge Fremr’s request for excusal from Trial Chamber VII (Annex I).

The Presidency recalls article 39(2)(b)(ii) of the Statute, rule 38 of the Rules and regulation 15(1) of the Regulations of the Court.

The Presidency hereby decides to recompose Trial Chamber VII as follows effective 17 March 2015:


