Trial Chamber VI of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Bosco Ntaganda* ('Ntaganda case'), issues the following 'Decision notifying the election of the Presiding Judge'.

- 1. On 18 July 2014, the Presidency of the Court constituted Trial Chamber VI, composed of Judge Kuniko Ozaki, Judge Robert Fremr and Judge Geoffrey Henderson, and referred to it the *Ntaganda* case. ¹ The judges of Trial Chamber VI elected Judge Robert Fremr as Presiding Judge. ²
- 2. On 18 March 2015, the Presidency re-composed Trial Chamber VI to be comprised of Judge Kuniko Ozaki, Judge Robert Fremr and Judge Chang-ho Chung.³ Pursuant to Regulation 13(2) of the Regulations of the Court, the judges of Trial Chamber VI, in its new composition, elected a Presiding Judge and HEREBY DECLARE that Judge Robert Fremr is the Presiding Judge.
