**Trial Chamber I** of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé* ('Gbagbo and Blé Goudé case'), issues the following 'Decision notifying the election of the Presiding Judge and designating a Single Judge'.

1. On 17 September 2014, the Presidency of the Court re-constituted Trial Chamber I, composed of Judge Cuno Tarfusser, Judge Olga Herrera Carbuccion and Judge Geoffrey Henderson, and referred to it the case of *The Prosecutor v. Laurent Gbagbo* ('Gbagbo case').<sup>1</sup>
2. On 20 December 2014, the Presidency of the Court referred the case of *The Prosecutor v. Charles Blé Goudé* ('Blé Goudé case') to Trial Chamber I, composed of Judge Cuno Tarfusser, Judge Olga Herrera Carbuccion and Judge Geoffrey Henderson.<sup>2</sup>
3. The judges of Trial Chamber I, both in the *Gbagbo* case<sup>3</sup> and in the *Blé Goudé* case, elected Judge Geoffrey Henderson as Presiding Judge.<sup>4</sup> They also designated the Presiding Judge as the Single Judge for the purposes of trial preparation in the two cases.<sup>5</sup>
4. On 11 March 2015, the Chamber issued a decision granting, *inter alia*, the Prosecution requests to join the *Gbagbo* and the *Blé Goudé* cases. It also declared that Judge Geoffrey Henderson was the Presiding Judge in the joint



case and designated him as the Single Judge for the purposes of trial preparation in the joint case.<sup>6</sup>

5. On 18 March 2015, the Presidency recomposed Trial Chamber I to be comprised of Judge Olga Herrera Carbuccion, Judge Geoffrey Henderson and Judge Bertram Schmitt.<sup>7</sup>
6. Pursuant to Regulation 13(2) of the Regulations of the Court, the judges of Trial Chamber I, in its new composition, elected a Presiding Judge and **HEREBY DECLARE** that Judge Geoffrey Henderson is the Presiding Judge.
7. Pursuant to Rule 132 *bis* of the Rules of Procedure and Evidence, the Chamber **DESIGNATES** the Presiding Judge, Geoffrey Henderson, as the Single Judge for the purposes of trial preparation in the *Gbagbo and Blé Goudé* case.


