THE JUDGES OF PRE-TRIAL CHAMBER I (the "Chamber") of the International Criminal Court issue the present decision on the election of the Presiding Judge.

- 1. On 13 March 2015, the Presidency, based on rule 4bis (2) of the Rules of Procedure and Evidence, assigned judges to divisions, whereby, inter alia, Judge Silvia Fernández de Gurmendi was assigned to the Appeals Division, Judge Joyce Aluoch was assigned to the Trial Division and Judges Cuno Tarfusser and Péter Kovács were assigned to the Pre-Trial Division in accordance with article 39(1) of the Rome Statute (the "Statute").<sup>1</sup>
- 2. On 16 March 2015, the Presidency attached temporarily Judge Joyce Aluoch to the Pre-Trial Division pursuant to article 39(4) of the Statute and constituted the Chamber anew.<sup>2</sup> The situation in the Republic of Côte d'Ivoire was assigned to this Chamber.<sup>3</sup>
- 3. The Judges of the Chamber note regulation 13(2) of the Regulations of the Court, pursuant to which the judges of each Pre-Trial Chamber shall elect from amongst their members a Presiding Judge.
- 4. The Judges of the Chamber also note the meeting of judges on 24 March 2015 during which it was decided that Judge Joyce Aluoch will act as the Presiding Judge of the Chamber with immediate effect.
