Trial Chamber VI ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Bosco Ntaganda*, having regard to Article 64(3) of the Rome Statute, Rule 132(2) of the Rules of Procedure and Evidence and Regulation 54 of the Regulations of the Court, issues the following 'Order scheduling a status conference on 21 April 2015 and setting the agenda'.

- 1. On 17 February 2015, the Chamber held a status conference during which it announced that the next status conference would be held in April in order to ensure that trial preparation proceeds smoothly.¹
- 2. The Chamber hereby schedules the next status conference for 21 April 2015.

Should the parties, the Legal Representatives of Victims or the Registry wish to raise any particular issues under agenda item e), they are requested to inform the Chamber and, if appropriate, the other party and participants thereof by Thursday 16 April 2015 at 16.00, by way of e-mail to 'Trial Chamber VI Communications'.
