Trial Chamber I ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*, having regard to Article 64(3) of the Rome Statute ('Statute'), Rule 132(1) of the Rules of Procedure and Evidence ('Rules') and Regulation 54 of the Regulations of the Court, issues the following 'Order setting the final agenda for the status conference of 21 April 2015'.

- 1. On 11 March 2015, the Chamber issued a decision granting the Prosecution requests to join the cases of *The Prosecutor v. Laurent Gbagbo* and *The Prosecutor v. Charles Blé Goudé*. In the same decision, the Chamber indicated that a status conference will be held on 21 April 2015 and instructed the parties and participants to submit observations on the items mentioned in the provisional agenda.<sup>1</sup>
- 2. On 14 April 2015, the parties, the Legal Representative of Victims ('LRV') and the Registry filed their observations. <sup>2</sup> The Defence team for Mr Gbagbo ('Gbagbo Defence') filed additional observations on the time needed to prepare for trial.<sup>3</sup> As these observations pertain to agenda items 'a) Timing, volume and modalities of disclosure of evidence pursuant to Rule 76 of the Rules' and 'i) Commencement date of the trial', <sup>4</sup> the Chamber considers that they should

have been included in the Gbagbo Defence's submissions in preparation for the status conference, for which an extension of ten pages had been granted.<sup>5</sup>

- 3. Taking into account the observations made in preparation for the status conference by the parties, the LRV and the Registry, the Chamber hereby issues a final agenda:
  - a) Timing, volume and modalities of disclosure of evidence pursuant to Rule 76 of the Rules;
  - b) Whether the Office of the Prosecutor ('Prosecution') anticipates additional issues concerning the protection of witnesses and other persons (including the need for redactions), the disclosure of identities of witnesses, as well as referrals to the Court's witness protection program;
  - c) Material already disclosed and intended to be disclosed by the Prosecution pursuant to Article 67(2) of the Statute and Rule 77 of the Rules;
  - d) Languages to be used in the proceedings, in particular, the languages spoken by the witnesses the parties intend to call and victims the LRV may seek authorisation to call;
  - e) Agreements as to evidence;
  - f) Conduct of proceedings, including the timing within which the Prosecution should communicate to the defence teams the order of appearance of the witnesses it intends to call;<sup>6</sup>
  - g) Filing of auxiliary documents in relation to the charges;<sup>7</sup>

- i) Commencement date of the trial.
