Judge Cuno Tarfusser, Single Judge exercising the functions of the Chamber in the present case, issues this order reclassifying documents in the record of the case under regulation 23 *bis* (3) of the Regulations of the Court.

- 1. The Single Judge notes articles 54(3)(f), 57(3)(c) and 68(1) of the Rome Statute. For the purpose of issuance of the present order, the Single Judge has reviewed the record of the case and taken into account the submissions of the Prosecutor of 7 May 2015 (ICC-02/04-01/15-231 and annexes) and a report of the Registrar dated 8 May 2015 (ICC-02/04-01/15-233 and annexes). Given that supplementary submissions are still expected of the Prosecutor, the present order does not address all filings in the record of the case. The Single Judge will decide on the appropriate level of classification of the remaining non-public documents upon receipt of the Prosecutor's supplementary submissions.
- 2. A number of documents in the record of the case are to be reclassified as "public", "confidential" or "confidential, *ex parte*, only available to the Prosecutor and/or the Defence", as specified below. In respect of documents which originate in the record of the case of *The Prosecutor v. Joseph Kony* et al., the level of classification is adapted in both records.
- 3. For documents which require a stricter level of classifications, the parties should file confidential or public redacted versions as appropriate. Any public redacted versions of documents copied from the record of the *Kony* et al. case should also be filed in that record.
- 4. For the sake of clarity of the record, the Single Judge notes that in spite of the Prosecutor's submissions certain documents need not be reclassified as they are already available to the Defence and their reclassification as public does not appear appropriate (ICC-02/04-01/15-3-Conf-Exp-AnxA, ICC-02/04-01/15-3-Conf-Exp-AnxB, ICC-02/04-01/15-3-Conf-Exp-AnxC, ICC-02/04-01/15-2-Conf-Exp-AnxC, ICC-02/04-01/15-2-Conf-Exp-AnxC, ICC-02/04-01/15-2-Conf-Exp-AnxC,

- 5. Upon the Prosecutor's suggestion, it is also appropriate to copy into the record of the case certain other annexes, relevant to the present case, to the Prosecutor's application under article 58 of the Statute, and to make them available to the Defence.
- 6. The record currently contains two confidential redacted versions of the Prosecutor's application for a warrant of arrest under article 58 of the Statute (ICC-02/04-01/15-3-Conf-Red and ICC-02/04-01/15-3-Conf-Red2) each of which contains several redactions which are not present in the other. It is therefore necessary that the Prosecutor review both documents and file in the record of the case a third redacted version which redacts only information which is redacted in both current redacted versions.

FOR THESE REASONS, THE SINGLE JUDGE
