Trial Chamber VII (the 'Chamber') of the International Criminal Court, in the case of The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido, having regard to Articles 60(3) and 61(11) of the Rome Statute ('Statute'), and Regulation 51 of the Regulations of the Court, issues the following 'Order Requesting Observations from Relevant States on Interim Release'.

- 1. On 29 May 2015, the Appeals Chamber reversed decisions made by a Pre-Trial Chamber II Single Judge to release the five accused in this case.<sup>1</sup> Determinations under Article 60 of the Statute were remanded to this Chamber as a consequence of these rulings.
- 2. On 19 June 2015,<sup>2</sup> each of the accused filed observations on detention or release. Mr Bemba withdrew his request for release.3
- 3. Mr Kilolo, Mr Mangenda, Mr Babala and Mr Arido all submit that continued release is justified in part because of their conduct since their release.4 For purposes of its decision on interim release, the Chamber seeks observations from the host State and from the States to which each of these four accused has been released. The Chamber will decide if any further responses to these observations are necessary once they have been received.
