Judge Geoffrey Henderson, acting as Single Judge on behalf of Trial Chamber I ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*, having regard to Rule 73 of the Rules of Procedure and Evidence ('Rules') and Regulation 24 of the Regulations of the Court, issues the following 'Order for submissions by the defence for Mr Blé Goudé concerning potentially privileged material'.

1. On 19 May 2015, the Prosecution requested that the Chamber review certain material potentially covered by attorney-client privilege ('Material') with respect to Mr Blé Goudé ('Prosecution Request').¹
2. On 20 May 2015, the Chamber instructed the Registry to notify the Prosecution Request and the potentially privileged material to the defence for Mr Blé Goudé ('Blé Goudé Defence').²
3. The Single Judge considers it appropriate to order the Blé Goudé Defence to review the Material, and to indicate by way of written filing whether the Blé Goudé Defence asserts that the Material, or any part thereof, is protected by any privilege. Submissions in this regard should identify the specific legal basis upon which privilege, if any, is asserted, but should not reveal any information in relation to which the Blé Goudé Defence asserts privilege. In setting the deadline for these submissions, the Single Judge has considered, in particular, that the Blé Goudé Defence has had access to the Prosecution Request and Material for more than one month.

FOR THE FOREGOING REASONS, THE CHAMBER HEREBY


ORDERS the Blé Goudé Defence to make submissions in accordance with the instructions given in paragraph 3 above no later than 29 June 2015; and
