The Appeals Chamber of the International Criminal Court,

In the review by the Court concerning reduction of sentence of Mr Germain Katanga pursuant to article 110 of the Statute,

Recalling that, on 07 March 2014, Trial Chamber II sentenced Mr Germain Katanga to a sentence of twelve years imprisonment (ICC-01/04-01/07-3436), which Mr Katanga accepted and chose not to appeal on 25 June 2014 (ICC-01/04-01/07-3498),

Noting that Mr Germain Katanga will have served two thirds of the sentence imposed on 18 September 2015,

Considering that article 110 (3) of the Statute provides in relevant part that "[w]hen the person has served two thirds of the sentence, [...] the Court shall review the sentence to determine whether it should be reduced",

Considering that rule 224 (1) of the Rules of Procedure and Evidence provides that "[f]or the application of article 110, paragraph 3", three judges of the Appeals Chamber are to be appointed by that Chamber for purposes of conducting the review concerning reduction of sentence,
