DIRECTIONS

- 1. The Appeals Chamber hereby suspends the running of the applicable time limits for the filing of the document in support of appeal and related submissions pending a decision on the admissibility of the appeal. Subject to the decision of the Appeals Chamber on the admissibility of the appeal, directions will thereafter be given with regard to the timing and length of the submissions on the merits of the appeal.
- 2. The Prosecutor is invited to make further submissions on the admissibility of the appeal, if deemed necessary, by 16h00 on Friday, 14 August 2015.
- 3. Should the Prosecutor file further submissions on the admissibility of the appeal, the Union of the Comoros may respond to such submissions by 16h00 on Wednesday, 19 August 2015.
- 4. The victims who have communicated with the Court and are represented by Ms Paolina Massidda from the Office of Public Counsel for victims and Mr Geoffrey Nice and Mr Rodney Dixon may, if deemed necessary, submit observations on the admissibility of the appeal by 16h00 on Wednesday, 19 August 2015.
