**Judge Geoffrey Henderson**, acting as Single Judge ('Single Judge') on behalf of Trial Chamber I of the International Criminal Court, in the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*, having regard to Articles 60(3), 61(11), 64(3)(a) of the Rome Statute and Rules 118(3) and 132(2) of the Rules of Procedure and Evidence, issues the following 'Order scheduling a status conference and a hearing on detention'.

1. On 21 April 2015, the Chamber held its first status conference in the joint case.<sup>1</sup>
2. On 7 May 2015, the Chamber set the commencement date for the trial for 10 November 2015, directing, *inter alia*, the Prosecution to provide full disclosure of all material to the Defence, pursuant to Article 67(2) of the Statute and Rules 76 and 77 of the Rules, no later than 30 June 2015. By the same date, the Prosecution was directed to provide to the Defence its list of witnesses and list of evidence to be relied on at trial and to disclose the reports of any expert witnesses to be called by the Prosecution.<sup>2</sup>
3. On 1 May 2012, the Defence for Mr Laurent Gbagbo ('Mr Gbagbo') submitted the 'Defence application for the interim release of President Gbagbo'.<sup>3</sup>
4. Hearings on detention were thereafter held in 2012, 2013 and 2014 pursuant to Rule 118(3) of the Rules.<sup>4</sup>



5. The Chamber hereby informs the Registry, parties and participants that it will hold a status conference and a hearing on detention on 25 September 2015 with the following provisional agenda:
  - a) Updates on any matters relating to the commencement of trial, including:
    - i. Disclosure, and
    - ii. Languages to be used during the proceedings;
  - b) Updates on consultations to jointly agree on expert witnesses;
  - c) Updates on the progress made to reach agreements about non-contentious issues; and,
  - d) Any matters relating to the detention of the accused persons.
6. Should the parties or participants wish to add other items to the agenda, the Chamber requests that they email such proposals by 21 September 2015 to 'Trial Chamber I Communications'.

**FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY**

**SCHEDULES** a status conference and hearing on detention on 25 September 2015 at 10h00.
