**Judge Geoffrey Henderson**, acting as Single Judge on behalf of Trial Chamber I ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*, having regard to Articles 64(2) and 67 of the Rome Statute and Regulation 23 *bis* of the Regulations of the Court, issues the following 'Order instructing the parties and participants to file public versions of their respective filings related to the "Decision on the fitness of Laurent Gbagbo to stand trial"'.

- 1. On 27 November 2015, the Chamber issued the 'Decision on the fitness of Laurent Gbagbo to stand trial',<sup>1</sup> in which it noted that 'numerous [related] filings within the record have been classified as confidential' and indicated it would issue an order setting a timetable for the parties and participants to file public redacted versions thereof.
- 2. To ensure that the record of the present case is public to the extent possible, and in accordance with the principle of publicity of the proceedings, the parties and participants are instructed to file or propose public versions, with redactions if necessary, of their respective filings, in accordance with the directions set out below.
- 3. In relation to the confidential, *ex parte* (Defence and Registry only) annex to the Registry's 'Transmission of the Detention Centre Medical Officer's assessment of the health condition of Mr. Laurent Gbagbo'<sup>2</sup> filed on 6 October 2015, the Single Judge notes the response of the defence for Mr Laurent Gbagbo ('Gbagbo Defence' and 'Mr Gbagbo', respectively) of 22 October 2105 submitting that Mr Gbagbo had not provided his written consent to the Medical Officer for the

purposes of this filing.<sup>3</sup> The Single Judge also notes the observations of the Registry<sup>4</sup> in which it indicated that the Detention Centre Medical Officer had reported to the Registry that Mr Laurent Gbagbo ('Mr Gbagbo') gave his consent to release his medical records, but that the Registry understood that to mean that the Medical Officer had received his *written* consent. In light of these circumstances and of Regulation 156(2) of the Regulations of the Registry, the Single Judge considers that an *ex parte*, confidential version of this annex need not be filed.<sup>5</sup>

## FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY
