
Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber VII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido*, issues the following 'Decision on Two Kilolo Defence Requests Related to D21-0003'.

1. On 4 February 2016, the defence team for Mr Kilolo ('Kilolo Defence') requested the Chamber to order certain protective measures for D21-0003.¹ As noted by the Kilolo Defence, this witness was granted these same measures in case ICC-01/05-01/08. This order continues to have full force and effect before this Chamber.²
2. That same day, the Kilolo Defence also requested the Chamber to order the Registry to identify a qualified counsel for D21-0003 for the purposes of Rule 74 of the Rules (which governs '[s]elf-incrimination by a witness').³ The Registry has already been directed to make all necessary arrangements to provide independent legal advice in these situations.⁴ No further order is necessary.

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

DISMISSES the relief sought by the Kilolo Defence in these two requests as moot.
