**Trial Chamber IX** ('Chamber') of the International Criminal Court ('Court') issues the following 'Decision Notifying the Election of a Presiding Judge and Single Judge', in the case of *The Prosecutor v. Dominic Ongwen* ('Ongwen case'), pursuant to Rule 132 *bis* of the Rules of Procedure and Evidence ('Rules') and Regulation 13(2) of the Regulations of the Court ('Regulations').


1. On 2 May 2016, the Presidency of the Court constituted Trial Chamber IX, composed of Judges Bertram Schmitt, Peter Kovacs and Raul C. Pangalangan, and referred to it the *Ongwen* case.<sup>1</sup>
2. On the same day, pursuant to Rule 132 *bis* of the Rules and Regulation 13(2) of the Regulations, the judges of the Chamber elected Judge Bertram Schmitt as Presiding Judge and as Single Judge for the preparation of the trial.


**FOR THE FOREGOING REASONS, THE CHAMBER HEREBY**
