Ahmad Al Faqi Al Mahdi* ('Al Mahdi case'), pursuant to Rule 132 *bis* Rules of Procedure and Evidence ('Rules') and Regulation 13(2) of the Regulations of the Court ('Regulations').


1. On 2 May 2016, the Presidency of the Court constituted Trial Chamber VIII, composed of Judges Antoine Kesia-Mbe Mindua, Bertram Schmitt and Raul C. Pangalangan, and referred to it the *Al Mahdi* case.<sup>1</sup>
2. On 3 May 2016, pursuant to Rule 132 *bis* of the Rules and Regulation 13(2) of the Regulations, the judges of the Chamber elected Judge Raul C. Pangalangan as Presiding Judge and Single Judge.

**FOR THE FOREGOING REASONS, THE CHAMBER HEREBY**

**DESIGNATES** Judge Raul C. Pangalangan as the Presiding Judge; and

**DESIGNATES** Judge Raul C. Pangalangan as the Single Judge.


