Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, issues the following 'Order requesting observations from relevant States on interim release', in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Articles 60(3) and 61(11) of the Rome Statute and Regulation 51 of the Regulations of the Court.

- 1. On 23 May 2016, the Single Judge ordered the defence for Dominic Ongwen ('Defence') to submit any submissions on Mr Ongwen's continued detention or release by 13 June 2016.¹
- 2. On 13 June 2016, the Defence filed its 'Defence Request for Conditional Release, or in the Alternative, the Restoration of Mr Ongwen's Communication Privileges', in which it requests, *inter alia*, that the Chamber grant Mr Ongwen interim release pending trial to the Republic of Uganda, with or without conditions.³
- 3. For the purposes of the upcoming decision on interim release, the Single Judge seeks observations from the Host State and from the Republic of Uganda. The Chamber will decide if any further responses to these observations are necessary once they have been received.

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

4. **ORDERS** the Registry to invite the Kingdom of the Netherlands and the Republic of Uganda to submit any observations on the interim release of Dominic Ongwen by 7 July 2016.
