1. On 21 March 2016, the Chamber issued its Judgment pursuant to Article 74 of the Rome Statute (“Statute”), convicting Mr Jean-Pierre Bemba Gombo under Article 28(a) of the Statute of the crimes against humanity of murder and rape, and the war crimes of murder, rape, and pillaging.<sup>1</sup> The Decision on Sentence pursuant to article 76 of the Statute was issued on 21 June 2016.<sup>2</sup>
2. On 6 July 2016, having excused Judge Sylvia Steiner and Judge Kuniko Ozaki from Trial Chamber III, the Presidency decided that the Chamber shall be composed as follows:<sup>3</sup>
  - Judge Joyce Aluoch
  - Judge Geoffrey Henderson
  - Judge Chang-ho Chung
3. On 8 July 2016, the judges of Trial Chamber III elected a Presiding Judge in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* pursuant to Regulation 13(2) of the Regulations of the Court and **HEREBY DECLARE** that Judge Joyce Aluoch is Presiding Judge in the case.


