TRIAL CHAMBER II of the International Criminal Court (the "Chamber"), acting pursuant to article 75 of the Rome Statute and regulation 34 of the Regulations of the Court (the "Regulations"), issues the following order.

I. Procedural background

- 1. On 9 February 2016, the Chamber instructed the Trust Fund for Victims (the "TFV") to supplement the draft implementation plan (the "Draft") submitted on 3 November 2015 (the "Order of 9 February 2016").¹ In this regard, the Chamber instructed the TFV to prepare a file on each potential victim and to provide a first batch of files to the Chamber by 31 March 2016, a second batch by 15 July and a third batch by 31 December 2016 (the "first limb of the Order of 9 February 2016").² The Chamber further instructed the TFV to continue developing the programmes proposed in the Draft and to impart to the Chamber full details of the initial batch of reparation programmes by 7 May 2016 (the "second limb of the Order of 9 February 2016").³
- 2. Having been accorded further time,⁴ the TFV submitted a first batch of files on 31 May 2016.⁵ The TFV also requested the Chamber to reconsider the approach laid down in its Order of 9 February 2016 (the "Document of 31 May 2016").⁶
- 3. On 7 June 2016, after again being accorded further time,⁷ the TFV submitted a document on the reparations projects (the "Document of 7 June 2016").⁸
- 4. On 1 July 2016, at the behest of the Chamber,⁹ the Office of Public Counsel for Victims¹⁰ (the "OPCV"), the Legal Representatives of the V01¹¹ and V02¹² groups of

victims (the "Legal Representatives of V01 and V02 victims") and the Defence team for Thomas Lubanga Dyilo (the "Defence")¹³ tendered consolidated observations (the "Consolidated Observations") on the Document of 31 May and the Document of 7 June 2016. The OPCV observations included proposals for the implementation of the Order of 9 February 2016¹⁴ and moved the Chamber "[TRANSLATION] to entertain [its] observations [...]". ¹⁵

- 5. On 14 July 2016, the TFV filed a second batch of files on victims potentially eligible for reparations in the case.¹⁶
- 6. On 15 July 2016, the Chamber ordered the Registry to provide the Legal Representatives of victims and the Trust Fund for Victims with all the necessary and appropriate aid and assistance for the purpose of locating and identifying victims potentially eligible for reparations.¹⁷
- 7. On 16 September 2016, the OPCV brought a motion informing the Chamber of developments since the Order of 15 July 2016 and seeking its guidance as to the desired arrangements "[TRANSLATION] to move forward reparations proceedings in the case" (the "OPCV Motion").

II. Analysis

- 8. The Chamber is of the view that, for the proper conduct of the present proceedings, time limits for observations on the OPCV Motion must be set pursuant to regulation 34 of the Regulations.
- 9. Having regard to the points raised in the OPCV motion, which, in essence, rehearse those made in the Consolidated Observations, and given the time frame laid down in its Order of 9 February 2016, the Chamber is minded to set relatively short time limits.
- 10. Accordingly, the Chamber instructs the TFV to file observations on the OPCV Motion by 26 September 2016.
- 11. Since the Registry was instructed to provide aid and assistance for the purpose of locating and identifying victims potentially eligible for reparations, the Chamber further directs observations on the OPCV Motion from the Registry by 26 September 2016.
- 12. Lastly, to allow the Legal Representatives of the V01 and V02 Victims and the Defence to make observations on the OPCV Motion which take account of those which the TFV and the Registry are to provide by 26 September 2016, the Chamber instructs them to do so by 29 September 2016.

FOR THESE REASONS, the Chamber

INSTRUCTS the TFV and the Registry to file observations on the OPCV Motion by 26 September 2016; and

INSTRUCTS the Legal Representatives of the V01 and V02 Victims and the Defence to file by 29 September 2016 observations on both the OPCV Motion and the observations of the TFV and the Registry to be filed by 26 September 2016.
